## **Summary**

Howard is sole principal of The Howard Jenkins Consultancy in Winchester, Hampshire and a consultant Chartered Building Surveyor. Having qualified in 1981 in the building surveying discipline of the Royal Institution of Chartered Surveyors (RICS) Howard has gained significant experience in building construction, the procurement process, building conservation, building surveys, defect analysis, dilapidations, party wall matters, contractual disputes and professional performance.

Howard has been in private practice on his own account since 1982, both as a partner in his own practices and as senior consultant to a PLC Group. Howard now focuses on consultancy advice in party wall matters (not least in London) dilapidations and he frequently acts as expert advisor and expert witness in a wide range of construction and property disputes from modest domestic disputes to large commercial matters.
